3. Public Portion

Daniel Woleski was present and made the following statement:

From the public’s point of view they are two excellent appointments. As you know in the past some of our police chiefs have not always been as popular as others. The Board discussed several items on the LTA report from SGT Boulton.

- Discussion on mayor's office request to evaluate reversing one-way traffic on Cottage Street between Elizabeth Street and Caroline Street. Based on the investigation conducted, SGT Boulton recommended that the request be denied.
- Discussion regarding the request made by the director of Derby Public Library to post multiple parking spaces along Caroline Street for the library's use. The director stated that parking is limited due to do Irving School. The area was monitored for approximately one month and it was determined that parking spaces were easily found throughout the day. Therefore, SGT Boulton recommended that the request be denied.

Chairman Estwan motioned to accept the recommendations made by SGT Boulton. Commissioner DiSorbo seconded and the motion passed with all in favor.

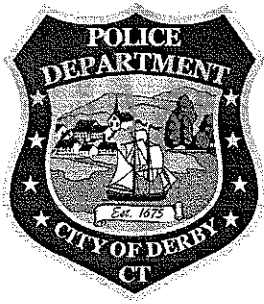
