Commissioner Estwan: "I don't have a definitive answer, but I will tell you that it is in process and it is being reviewed."

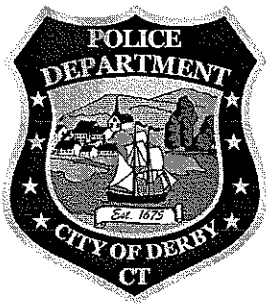
Mr. Heusser: "It's been six months."

Estwan: "Ok."

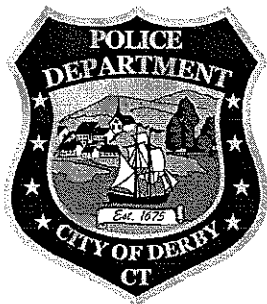
No one else from the public wished to address the commission and public portion was closed.
